## THE SONGS FOR RIGHTS METHODOLOGY

While all our workshops, trainings, and learning materials are tailor-made and adapted to the specific target group, the Songs for Rights methodology is based on the LACPA approach. The following represents the 5 typical steps of a Song for Rights workshop or training:

#### L – LEARN

Learning about human rights, key principles, and international conventions on human rights using musical activities, exercises and games.

#### **A - ASSIMILATE**

Internalizing the meaning and importance of Human Rights in our lives by analyzing and discussing which aspects of Human Rights play an important role in our countries, communities and close environment.

#### **C - CREATE**

Writing and composing a human rights song based on the learning from the previous steps and the emotional connections we have built towards the topic and the group.

#### **P - PRODUCE**

Recording the song in a studio, or using DIY and low-tech tools, and the production of a music video.

#### A - ADVOCATE

Promoting human rights through different channels and actions using the produced song & video.

## **LEARNING MODULES**

The training is hands-on, interactive and praxis-oriented. Participants gain knowledge through online coaching (one before the training and one after), 4 intensive training days at the Landesmusikakademie Berlin and training material in the form of a toolkit and video tutorials.

To foster learning, you will go through a wide range of activities and exercises in the role of workshop participant, as well as facilitator, and will get feed-back from the trainers. You will also write, compose and record your own song during the training.

Topics you will explore include understanding human rights and their principles, identifying human rights violations in your country, community, or school, learning how to write and compose songs about human rights issues, recording and producing music videos, and tips and tricks for setting up and running Songs for Rights workshops.
