- by developing innovative programs worldwide to address the lack of fundamental human rights knowledge, affecting over 50% of the world's population.

WE TACKLE SOCIAL INJUSTICE AND INEQUALITY

- by addressing root causes. With the top 1% holding 43% of global wealth and 258 million children out of school due to poverty and discrimination, our projects promote equality, justice, cultural understanding, and unity.

WE FOSTER INCLUSION

- by addressing discrimination through education, music, and advocacy, targeting marginalized communities and people to become active agents of change.

We envision a world where music connects people, amplifies human rights, promotes creative expression and diverse perspectives.

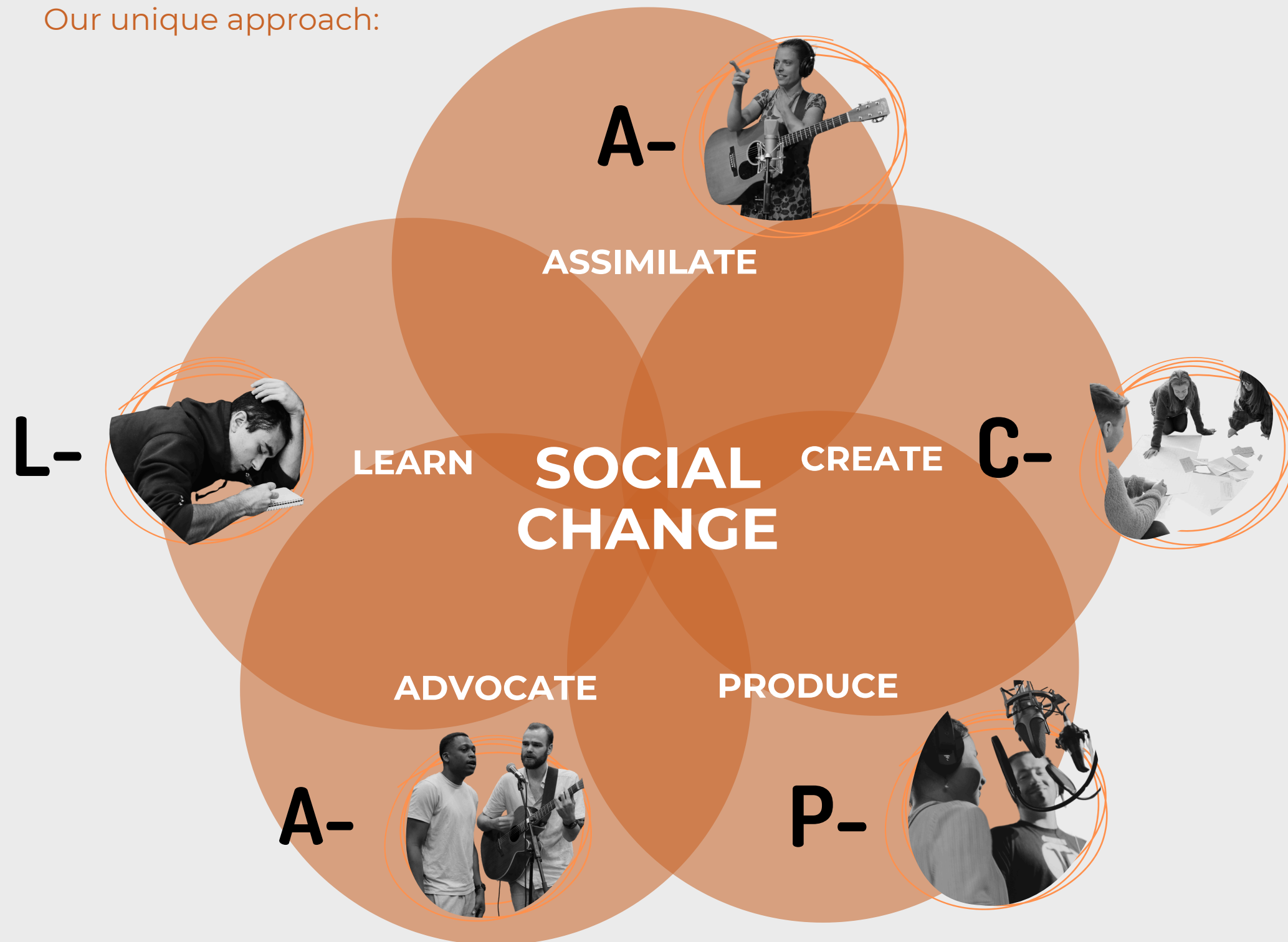

LACPA METHOD

Our unique approach:



L – Learn:

Learning about human rights, key principles, and international conventions on human rights.

A -Assimilate:

Internalizing the meaning and importance of Human Rights in our lives

C – Create:

Writing and composing a human rights song

P – Produce:

Recording of the song and production of a video clip

A – Advocate:

Promoting human rights using the produced song & video

IMPACT

Uplifting voices, promoting inclusivity, equality and social justice.

Marginalized groups, engage with human rights through innovative music-based learning, gaining new skills, expressing themselves creatively and advocating for change.

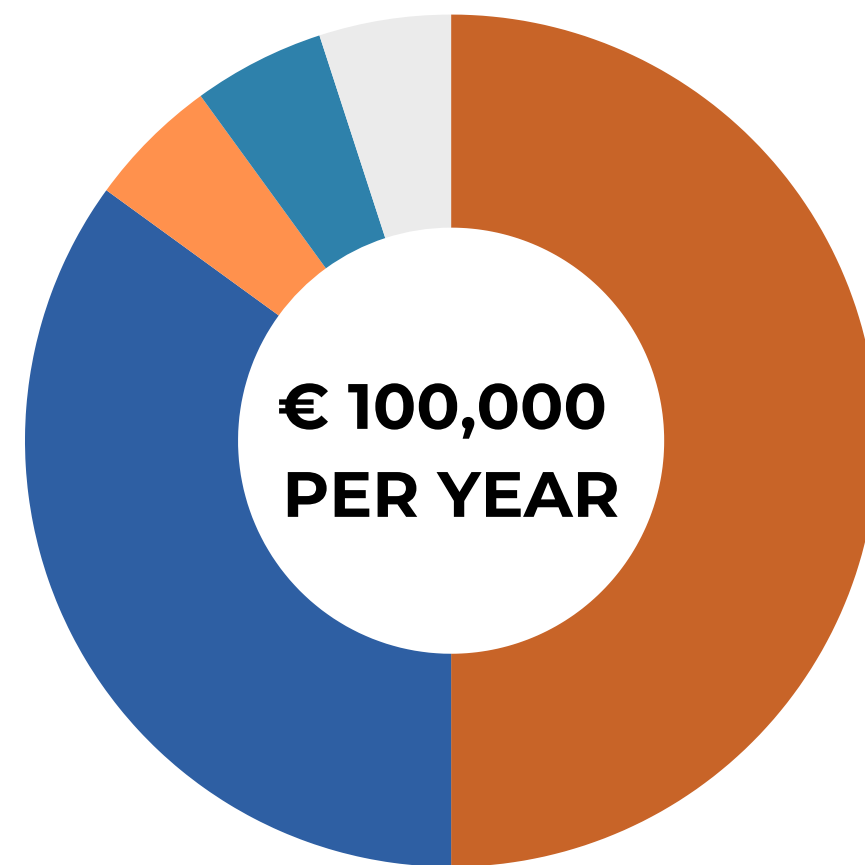
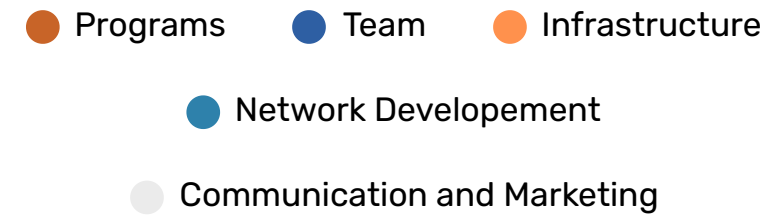
By 2027, our initiatives will empower:

- 400 through youth workshops
- 200 through trainer programs
- 1000 through large-scale projects
- 400 through our network and membership scheme, including online learning
- 10,000 community stakeholders will benefit indirectly, and half a million people will be reached through our music, videos, and advocacy work.

3 YEAR INVESTMENT

Operational grant of **100,000 €** per year will be matched with a minimum of **200%** match funding

SUPPORT SCALING OUR WORK

By amplifying the voices of human rights.

3-year plan: (by 2027):

- 8 Songs for Rights workshop series and training for trainers' programs
- 5 large-scale projects (ERASMUS+, Creative Europe, CERV, ...)
- 3 CSR programs
- 2.000 direct beneficiaries; 10.000+ indirect beneficiaries
- 50 produced songs & music videos
- 35 new network members
- 5 permanent staff members

By 2030

we will reach **10.000 direct beneficiaries**, 500.000 through our songs, music videos, and advocacy efforts and build a global network
